

BCRR Board Minutes May 19, 2020 7:00 pm Online Virtual Meeting

Review Meeting Minutes from last month – Minutes approved

Treasurer Report:

- BCRR account: \$35,200 balance, no recent expenses. Received \$1200 garage sale proceeds, \$254 Signmeup membership dues.
- Alex's 5K account: \$23,100 balance. Dave is owed \$150 because he shockingly managed to find and submit his receipts. Sarah sent donation checks for Westview, Autism Speaks and Avondale to Kathi M., who will forward them to the recipient organizations. No check presentation ceremonies due to social distancing. Checks have not been cashed yet.
- Bayou Bash Relay account: \$3,000 balance. Relay will be postponed, permit fees will be refunded from city. No other expenses or revenues.

Newsletter/Website:

- Next newsletter will likely be August or September.
 - Topics: Virtual races
- Website analytics: Joe shared options for online advertising including social media "boosts" or search engine keyword advertising. Joe has tested various Google searches and believes that at least Houston Fit is already buying Google keyword advertising for relevant terms. The board agreed that gaining new members during the pandemic is unlikely, so any advertising campaign should wait until social distancing is relaxed. At that time, a small test on three different platforms with a similar budget will be performed to assess cost and effectiveness of an advertising campaign.

Bayou Bash Relay – May 2 2020

- The city communicated to Mike that July 18 is not available due to other activities in the park that day. Discussions are also ongoing whether the city will grant any event permits at all for the rest of the summer.
- Mike estimates that no additional financial commitments are needed until 2 to 3 weeks before the race, so there is no immediate pressure to decide when or if the race will occur
- The board agreed that minimum requirements to hold the race included city and county social distancing guidelines relaxed to allow such gatherings, and RRCA support to hold in-person events to ensure insurance coverage.

Spring Banquet – September 30, 2020

• The banquet deposit will be applied to the new date and no refund will be issued



• Further planning to follow in August/September

Pandemic Response/Resuming Club Operations

- The board agreed that minimum requirements to resume club operations included CDC guidelines relaxed to allow group activities, RRCA support to hold in-person club activities, HARRA support to hold in-person club activities.
- The first club activities to resume will be group runs, social events will not resume immediately.
- Modifications to water stations will be needed to resume group runs
 - No shared coolers/jugs. Individual 8oz water bottles, preferably spread out so there is no need to reach into the same packaging
 - Hand sanitizer available
 - Encourage members to carry their own water bottles
 - Discussed recruiting volunteers to man the aid stations to reduce contact and monitor compliance with the rules

Succession planning

 The current board will serve until the banquet in September. The extension of the term will be communicated in the weekly email and anyone with concerns will be encouraged to reach out to discuss.
