**Review Meeting Minutes from last month – Minutes approved**

**Treasurer Report:**

- BCRR account: \$42780 balance. \$265 in dues deposited. Deposited \$1200 garage sale cash.

**Pandemic Response/Resuming Club Operations:**

  - Some resistance from members to moving the Sun start location from the tennis center to the running center. Board agreed that for the time being the running center is the safest location to avoid crowds at the park.
  - Board will revisit Sun start location in January to decide if it is reasonable to return to tennis center.
  - Mellow Monday has moved locations from Memorial Park to Hermann Park to avoid crowds
