

BCRR Board Minutes February 9, 2021 6:00 pm Online Virtual Meeting

Review Meeting Minutes from last month – Minutes approved. Dave and Joel vociferously opposed their characterization as "slackers." However they presented no evidence to prove that they are not slackers. Motion to amend the minutes was not sustained.

Treasurer Report:

- BCRR account: \$44105 balance. Virtual marathon costs (porta potties and snacks/drinks) \$343. Joe submitted invoice for website management.
- Alex's 5K account: \$32406 balance. Still receiving runsignup deposits. Received wire transfer donation for anonymous T-shirt donor. Christina to follow up with Kathi on plans to distribute donations.
- Bayou Bash Relay account: \$3000 balance. No recent activity.

HARRA Equipment Rental

- John P contacted Christina with the message that HARRA intends to get out of the equipment rental business and sell or discard their race equipment. BCRR uses some of this equipment for Alex's 5K and Bayou Bash Relay.
- David contacted HARRA to discuss further. He found out that HARRA doesn't intend to get rid of everything as there is still a need to support Party in the Park and Bayou City Classic, the plan sounds like a clean up/downsizing more than a full exit from equipment rental. HARRA does intend to give up boat shed space. Planning to keep cones, tables and flooring at a minimum.
- David and Joel to compile an equipment list for BCRR events and identify which items we rent from HARRA. Suggested to contact John to set up a joint walk through with HARRA and BCC representatives to take inventory and assess whether remaining boat shed units will hold the items that are not being discarded.
- Board agreed that HARRA should make an effort to recruit members of other clubs to assist in the clean out, it should not be completed only by BCRR members.
